Chair's Report



This year's report marks a momentous period for Turning Point Scotland. It has been a real privilege to become Chair of this fantastic organisation after serving as Vice Chair. We have celebrated 20 years of developing innovative social care services and I would like to express my appreciation to colleagues past and present who have helped provide life changing support to people throughout Scotland.

On a personal note, I would like to thank our outgoing Chair, Dorothy McElroy, for her leadership of the Board of Trustee's during a period which saw ground breaking initiatives and advancement as Turning Point Scotland worked to raise awareness of blood borne viruses and further developed our services and involvement in the fields of Homelessness and Justice. I would also like to thank Sheila Fazal and Joanne Pike as they step down from our Board. Both brought a wealth of experience and commitment to their work as Trustees. We have been fortunate to recruit excellent new Trustees in Emma Skett, Graeme Cook and Lorna Gibbs. Their knowledge, creativity and fresh perspectives are already proving to be valuable assets as Turning Point Scotland targets another successful year.

Looking back, this year is clearly demarked into periods before and after the Covid-19 pandemic which feels like it has been at the

forefront of every conversation and decision in recent months.

In the period before the pandemic, our biennial staff conference focused on the theme "Sum of the Parts" and it has never been clearer that the success and growth of the organisation is based on the synergy of all of our colleagues working together with a shared vision of a Scotland where everyone has a safe place to call home, a support network of positive relationships and the chance to fill their time with meaningful and enjoyable activity.

We have also had a year of celebratory events. The First Minister Nicola Sturgeon visited our Head Office in Glasgow whilst our services including Inverclyde, Renfrewshire, Ayr and Prestwick hosted their own special occasions. Each were occasions where staff and some of the people we support were able to have fun together. Individual services also marked significant events. Elgin commemorated both the organisation and 20 years of their service and we marked milestones including 25 years of the Glasgow Drugs Crisis Centre and 20 years of our services in Dumfries & Galloway and Rosie's Social Enterprises.

Since the pandemic, our attention has understandably been devoted to the agile and responsive approach required to keep our services running, to support our service users and to keep our staff safe whilst doing so. On behalf of the whole board, I would like to extend our admiration and appreciation to all of those within Turning Point

Scotland whose continued commitment and resilience during this period of uncertainty has been crucial to our operations. The ability to continually prioritise the needs of those we support whilst remaining focused and dynamic has characterised Turning Point Scotland's response. It is both inspiring and ultimately provides a solid foundation for future success.

Neil and the Executive Team at Turning Point Scotland have provided great leadership in a rapidly changing landscape. The commitment of our senior team to shape adult social care by drawing on the ideas and experiences of our whole staff is true to our ethos that people matter.

As we celebrate the successes we have had and reflect on the growth we have achieved in Scotland's social care sector, we remain eager to continue to innovate and to shape our services around the needs of those we support. This year, perhaps more than any other, we have been delivering the objectives of our strategy whilst living out our organisational values every day.

The turbulence of a pandemic, remote working and economic upheaval represent very real challenges. There are however, exciting opportunities for staff and those that we support and both will be key to our organisation's future. As we look forward to the year ahead, I am confident that we can continue to create an environment where people can flourish and reach their potential ultimately achieving their own goals and aspirations.

Chief Executive's Report



Few of us would have predicted the extent to which our lives could change as a result of the Global Pandemic. Reflecting on what was a very successful year for TPS, there can be no doubt that the reality of COVID19 thrust us into an unprecedented series of challenges which dwarf pre- COVID issues in terms of complexity and significance.

There will, of course, be an appropriate opportunity to look back on Turning Point Scotland's response and performance during the Covid19 crisis, it is appropriate now to do the same for the period 2019-2020, for the sake of good governance and continuity. So how should our organisation view the year in question?

One key highlight of the year was the celebration of TPS 20th anniversary. The milestone marked across May and June saw a visit to our head office in Glasgow by the First Minister, Nicola Sturgeon, the first time we have ever hosted the Government leader. The anniversary also inspired a series of less formal celebrations held across our services in Scotland including those in Renfrewshire, Inverclyde, Ayr, Prestwick and Elgin.

Other services reaching milestones in this year included the Glasgow Drug Crisis Centre, which enjoyed its 25 year anniversary, whilst

Rosie's Café in Aberdeen, and services at D&G and Elgin saw their 20th also. I was personally very encouraged to see the enthusiasm demonstrated by staff and the people we support to mark this milestone occasion. I was struck by the obvious pride our staff took in these, and the inclusive nature of the events. These were for everybody involved with TPS; staff past, present and future, the people we support and their families, the stakeholders with whom we share our achievements and success. The anniversary events were above all, a chance to get together, enjoy the moment and then look to the future. It is also significant that we were afforded an afternoon of the First Minister's diary, reflecting the credibility and goodwill towards our organisation and its people.

Other political stakeholders to visit across the year included the opposition leader, Richard Leonard MSP, who saw first-hand the work and innovations of our team at the GDCC, Adam Tomkins MSP who engaged with the team at the Glasgow Homelessness Service, and Alison Thewliss MP who also visited GDCC. For me, these interactions with senior, national figures demonstrated growing interest in our work and the care support sector, as well as our own growing confidence in engaging to have our voice, as a social care developer and provider, heard effectively in policy-making arena's.

We continued to deliver and develop service innovations throughout 2019-20, and this was evidenced by new

service provision across LD, Mental health and addiction services across Scotland but particularly in Perth and Kinross; and the establishment of the new Glasgow Alcohol and Drug Residential Stabilisation service in Glasgow. It was the successfully established innovations in the form of the IEP (a mobile Injection Equipment Provision, offering clean needle exchange, run in partnership with NHS Greater Glasgow and Clyde) at GDCC, and Housing First Homeless services that provided the focus for the political stakeholder visits mentioned earlier.

The rising number of Drug-Related-Deaths in Scotland prompted the Government to form a Drug Deaths Taskforce in June 2019, which met for the first time in September the same year. I accepted an invitation to join this group in the capacity of Vice Chair, keen to bring the learnings our organisation has made, not just in addictions, but right across the spectrum of social issues we deal with, to a wider audience, and to put these learnings to profitable use in the context of this crisis. Turning Point Scotland has already been significantly involved in initiatives featuring a targeted, but wider, distribution of naloxone (an emergency treatment which reverses the effects of an opioid overdose) and access to support for those in the criminal justice system. Again, the creation of a Taskforce, featuring leaders from emergency support, public health, research, policy and lived experience backgrounds is another sign

of how social care issues are moving up the political agenda.

My final reflection and memory of the year is that of the staff conference that was held in Glasgow's Marriott Hotel, in November with over 200 staff attending. As an organisation that now employs over 1500 members of staff, events like this are vital to us in giving a platform for exchange of views, building personal networks, and collectively shaping the future path of our Turning Point Scotland. This event, along with our activities over the year, further consolidated our shared values and strong sense of duty to the people we support and our staff colleagues who consistently deliver at levels beyond those that could be expected of them.

The story of 2019-20 can be seen to be one of both further growth and also consolidation. We may be over 20 years old now, but are still young, undaunted and curious, and eager to make a difference. We may have over 1500 staff working in 36 services right across Scotland, but we see ourselves as one team, and make every effort to live and work by this. As the year in question ended in March 2020 with the Covid19 crisis beginning to escalate, the established foundations of TPS, coupled with the unity of our TPS family and commitment of staff, provided the strongest possible base from which to manage an unprecedented national crisis and will undoubtedly make us stronger as a result.
